In 2015-16 we added a formal parent advisory committee which met monthly on the dates outlined above. At each meeting, the group had an opportunity to learn about the services provided to the target students and review key metrics. The administrative council meets bimonthly and our meetings are separated into "strategic" where we spend more time in in-depth discussion about a topic essential to the forwarding of the mission of the Nevada Joint Union High School District. Our other meetings are called "tactical" where we review key metric data as it comes in and define what we need to do on the ground in the coming weeks. During our opportunities to meet and confer with the NJUHSTA we spent a bit of time analyzing data from our credit recovery system and found that while the system is working well at North Point Academy and for original credit, it is not working well for after school and summer school credit recovery. our credit recovery system and found that while the system is working well at North Point Academy and for original credit, it is not working well for after school and summer school credit recovery. Hence the decision was made to eliminate summers school and after school credit recovery after the current fiscal year and replace it with all original credit and credit recovery in the school day. One of the most interesting initiatives for our LCAP has been the idea of changing our school start time to align with the scientific research on teen sleep patterns. We convened a schedule steering committee of teachers from Bear River and Nevada Union to study the issue and make recommendations. The committee identified 4 priorities for a school schedule

The 2014/15 LCAP process was particularly challenging due to repeated changes in direction as the regulations were developed and adopted by California State Board of Education. Initial direction in a LCAP workshop hosted by the Placer County Office of Education on February 14, 2014 indicated that the LCAP was to be a strategic document focusing on large organizational goals for all students and the unduplicated count students. After subsequent State Board of Education meetings, the direction changed and the LCAP template released in March was complex and required significant staff time to understand and fill out. The 2015/16 template shows considerable improvement over the 2014/15 template. In order to increase stakeholder engagement, in addition to the two annual town hall meetings, we added a formal parent advisory committee, a parent survey to improve parent engagement. To improve student engagement, we added visits to confer with the unduplicated count students and circulated the draft LCAP to the entire school community. In order to improve teacher engagement we scheduled time during our staff development day to collect input from all interested teachers, expanded our meet and confer times, applied and were selected to participate in the first ever California Labor Management initiative. For next year, we will need to adjust to get further engagement from CSEA, further engagement from students, and assure that parent voices from the far





 - (1) The number of cohort members who dropout by the end of year 4 in the cohort where "cohort" is defined as the number of first-time grade 9 pupils in year 1 (starting cohort) plus pupils who transfer in, minus pupils who transfer out, emigrate, or die during school years 1, 2, 3, and 4.
 - (2) The total number of cohort members.
 - (3) Divide (1) by (2).
- (d) "High school graduation rate" shall be calculated as follows:
 - (1) The number of cohort members who earned a regular high school diploma [or earned an adult education high school diploma or passed the California High School Proficiency Exam] by the end of year 4 in the cohort where "cohort" is defined as the number of first-time grade 9 pupils in year 1 (starting cohort) plus pupils who transfer in, minus pupils who transfer out, emigrate, or die during school years 1, 2, 3, and 4.
 - (2) The total number of cohort members.

(3) Divide (1) by (2).

- (e) "Suspension rate" shall be calculated as follows:
 - (1) The unduplicated count of pupils involved in one or more incidents for which the pupil was suspended during the academic year (July 1 June 30).
 - (2) The unduplicated count of pupils with a primary, secondary, or short-term enrollment during the academic year (July 1 June 30).

(3) Divide (1) by (2).

- (f) "Expulsion rate" shall be calculated as follows:
 - (1) The unduplicated count of pupils involved in one or more incidents for which the pupil was expelled during the academic year (July 1 June 30).
 - (2) The unduplicated count of pupils with a primary, secondary, or short-term enrollment during the academic year (July 1 June 30).
