

# Nevada Joint Union High School District Independent Citizens' Bond Oversight Committee, Regular Meeting Minutes

## A. CALL TO ORDER

Committee Vice Chair Katy Schwarz called the meeting to order at 6:03 p.m.

# F.3 Overview of summer 2017 construction projects and introduction of the 2018 Bear River Track Project

While projecting before and after pictures of each project, as appropriate, Paul Palmer, Director of Construction and Planning, reviewed the progress of summer 2017 construction projects to date:

# **Nevada Union High School:**

# Gas Pipeline Replacement

A Measure B Projects Kick-off Ground Breaking Ceremony was held at the gas pipeline manifold on June 14th. The contractor for this project is Pacific Mechanical. The project is substantially complete, and, to date, there have been no approved change orders, although the contractor did encounter two very large rocks which required extra services to remove.

# **Don Baggett Theatre Exterior Painting**

The contractor for this project is Molitor Painting. There were numerous small cracks in the stucco, requiring extra repair work by the contractor. The project is 100% complete. Approved change orders to date are 5.21%.

# Re-roofing Buildings C & I

The contractor for this project is Sierra Single Ply. The re-roofing for both buildings is 100% complete. Building J's roof was damaged and required repair of the roof deck prior to installation of the new roof. Because of the repairs, our approved change orders to date are 9.84%.

# Football Field Replacement

The contractor for this project is FieldTurf through a CMAS contract. The total project is 50% complete with one change order for .16%.

# Re-roofing Buildings E & Theatre Complex

The contractor for this project is Sierra Single Ply. The total project is 50% complete; Building E is substantially complete. Approved change orders to date are 0%.

# Security Cameras

The contractor for this project is KS Telecom. Installation at Nevada Union High School is scheduled to being on or after September 18<sup>th</sup> with a projected completion date of November 30<sup>th</sup>.

# Public Address System (Front End)

The contractor for this project is Advance Sound & Electronics. The installation at Nevada Union is scheduled during the October 2017 break from October  $13^{th}$  through the  $22^{nd}$ .

# **Bear River High School:**

# Fire Shutter Doors Addition

The contractor for this project is Treehenge Construction. The project is 100% complete with approved change orders at 3.02%.

# Security Cameras

The contractor for this project is KS Telecom. Installation is ongoing and is scheduled to be substantially completed before school starts on August 15<sup>th</sup>. Approved change orders is 0%.

Attendees wanted to be sure the District disseminates information to the public informing them of the security camera installation, serving as a deterrent for vandalism and theft. Additionally, the importance of ensuring security cameras have a view of bicycle racks to deter theft, especially for those students who ride expensive bicycles to school, was stressed.

## Public Address System (Front End)

The contractor for this project is Advance Sound & Electronics. The installation is in place, and is scheduled to be substantially complete before school begins on August  $15^{th}$ .

#### New All-Weather Track

The total project is 10% designed. We're planning to use a CMAS contract with Beynon for construction of the track.

# **Silver Springs High School:**

## Security Cameras

The contractor for this project is KS Telecom. Installation is scheduled to begin on or after August 14th.

- F.5 Tour of the Bear River High School Campus

Paul Palmer guided the Committee on a tour of the Bear River campus. Special interest was paid to the progress of the Fire Shutter Door Installation project in the Ag/Mechanical shop and ongoing installation of Security Cameras. Additionally, Paul discussed the future need for new HVAC units for the various buildings. The District intends to study two options: replace hydronic piping (hot water distribution piping), which leaks, and install new "boxcar" rooftop HVAC units or install new Variable Refrigerant Flow HVAC units while abandoning the hydronic piping in place. Paul explained how challenging it will be to replace the hydronic piping as the piping goes underneath the campus courtyard landscaping and seatwalls. The Committee also looked at the current decomposed granite track, which is slated to be replaced with an all-weather track during the summer of 2018.
