6. DISCUSSION/ACTION ITEMS

6.1 Superintendent's Welcome

Mr. McFadden updated the Committee on the PSPS days that the district has had to date. We have used 5 to 6 days for the PSPS and fire related smoke days. A ton of work has been put into opening the district for the hybrid opening. Our maintenance and operations team has put in a tremendous amount of work for this to happen. He has found that the most effected groups of students have been EL and Silver Springs students. These students are having a very difficult time learning via distance education. Each site will be holding SST and Intervention meetings with these students and families. Brett, Laura, Jordan and Heather will meet soon to go over the remaining Measure B Bond money.

6.2 QUESTION AND ANSWER

- **H.N.** Thank you to the entire staff at NJUHSD for all of their additional work to get the sites open and students back on campus.
- **J.B.** She is on Bear River's Site Council and has seen firsthand just how difficult the online teaching has been for staff. The additional time, training and preparation that it takes.

R.K. - What about the culinary job?

- J.K. We are attempting to make the space larger, we have found that we may be able to knock down a wall and extend the classroom. The changes are still in DSA review. The LLB has not gone out for bid. We also have a CTE Grant that will be used for a portion of the job.
- B.M As we draw down Fund 21 (Measure B) staff will look at going for another bond possibly, is it feasible? Discussions will start after the first of the year.
- J.K. A shut out to Aurora Thompson our CTE Director for the \$7 million is CTE Grants
- L.F. Enrollment is down this year by 85 No prediction of an increase of enrollment until the 22/23 school year
